Monthly Sales Report--- Dec 2011

Taichung, Taiwan, Jan 5, 2012—**Siliconware Precision Industries Co., Ltd.** ("SPIL" or "the Company")(Taiwan Stock Exchange: 2325, NASDAQ: SPIL) today announced sales revenue for Dec 2011: on an unconsolidated basis, sales revenue was NT\$ 4,694 million, representing 3.7% sequential decline over November 2011. On a year-over-year basis, sales revenue for Dec 2011 declined 2.7%.

On a consolidated basis, sales revenue was NT\$ 5,103 million, representing 2.9% sequential decline over November 2011. On a year-over-year basis, sales revenue for Dec 2011 declined 3.9%.

On an unconsolidated basis, the Company's 4Q 2011 sales revenue were NT\$ 14,599 million, representing 3.5% sequential decline over 3Q 2011. On a year-over-year basis, sales revenue for 4Q 2011 increased 3.0%.

On a consolidated basis, the Company's 4Q 2011 sales revenue were NT\$ 15,712 million, representing 3.8% sequential decline over 3Q 2011. On a year-over-year basis, sales revenue for 4Q 2011 increased 1.5 %.

On an unconsolidated basis, the Company's 2011 full-year sales revenue were NT\$ 56,553 million, representing 5.9% sequential decline compared with the same period of year 2010.

On a consolidated basis, the Company's 2011 full-year sales revenue were NT\$ 61,237 million, representing 4.1% sequential decline compared with the same period of year 2010.
